

## **1. BACKGROUND**

Punjab Prisons Development Board (PPDB) is a body corporate under the Department of Prisons, Punjab. It has been constituted under the Punjab Prisons Development Board Act, 2020, and subsequently, Rules were framed there under.

## **2. AIMS AND OBJECTIVES**

PPDB is in the process of setting up of industries in various prisons of Punjab. The objective is to help the inmates learn new skills and keep them engaged in useful activities as it will reduce the crime and recidivism in jails. This will also help in revival of prison industries, which have been staying dormant for a while now.

## **3. EOI PROCESSING FEES**

A non-refundable processing fee for Rs. 5,000/- (Five Thousand Rupees only) in the form of a Demand draft or a Pay Order drawn in favor of "General Manager, Punjab Prisons Development Board-cum- Superintendent, Central Jail Patiala" Payable at Patiala has to be submitted along with the EOI response. Bids received without or with inadequate EOI processing fees shall be liable to get rejected.

## **5. TERMS AND CONDITONS**

(i) PPDB shall, provide the following facilities:

- (a) Space to install machinery, including covered /open space.
- (b) Unskilled labor for manufacturing the products.
- (c) Existing machinery on 'as and is where' basis.
- (d) Water, electricity, etc. on payment basis.

- (ii)** Salary of labor shall be paid by the PP on following rates:
- (a) Unskilled Labor Rs 100/- per day
  - (b) Semi-skilled Labor Rs.120/- per day
  - (c) Skilled Labor Rs.140/- Per day
- (iii)** Selected firm has to deposit Rs. 1,00,000/- as security.
- (iv)** There shall be maximum 2 shifts per day of 8 hours each.
- (v)** Unskilled labor to be provided by PPDB.
- (vi)** Security vetted skilled manpower and supervisors may be allowed from outside of the jail premises and given access inside the jail premises for manufacturing and training activities.
- (vii)** Manufacturing, sales and marketing shall be the sole responsibility of the Bidder.
- (viii)** Bidder shall clarify the number of inmates to be employed per day in the bid documents. Bidder shall try to employ as many inmates as possible.
- (ix)** The Gross expected turnover of the Unit is required to be quoted in the Bid.
- (x)** The bidder shall be ready to share at least 2% of the total revenue earned out of this business as royalty with PPDB (as fixed from time to time). The payment shall be made on quarterly basis. Selected firm shall transfer the royalty earned out in one quarter by 5<sup>th</sup> of start of next quarter.
- (xi)** The process for seizure of the infrastructure established by the firm shall be initiated, in case the firm fails to deposit the royalty as prescribed in clause (x) above.
- (xii)** Them Bidder is required quote minimum guaranteed monthly income to PPDB from the project.
- (xiii)** Bidder can use the existing machineries in the jail premises, if any.
- (xiv)** The finished products shall also bear the name and logo of PPDB and Govt. of Punjab, or as desired mutually.
- (xv)** The Bidder is liable to pay the lease/rent, electricity charges, wages etc., by 5<sup>th</sup> of every consecutive month.

- (xvi)** The plant and machinery must be labor intensive.
- (xvii)** The Bidder shall set up plant and machinery in the jail premises on its own cost.
- (xviii)** Cost for all installation and alternation of the premises, if any, shall be borne by the Bidder.
- (xix)** Bidder shall be responsible for renovation of existing structure, arranging and providing apparatus, machine tools, raw material and other devises and other necessary equipment required for imparting training and manufacturing products at their expense.
- (xx)** The Board will not be responsible for any kind of damage done by the labor deployed by the Board to machinery, finished goods or raw material.
- (xxi)** Bidder shall be responsible to get the required licenses, permissions, NOC's, etc. for setting up of manufacturing unit and manufacturing of goods.
- (xxii)** There shall be no any manufacturing activities on Jail Holidays.
- (xxiii)** Bidder shall abide by all the Rules & Regulations prescribed in the Jail Manual/Prison Acts and other relevant State, National and International laws.
- (xxiv)** Overall maintenance and up keep of the Unit shall be the sole responsibility of the Bidder.
- (xxv)** No outsourcing/sub-contracting shall be allowed.
- (xxvi)** The Bidder shall be responsible for arranging complete raw material, along with packing material required for the manufacturing process.
- (xxvii)** Bidder shall be responsible to give necessary training to the inmates for manufacturing activities.
- (xxviii)** The period of the project will be 3 years which may be further extended subject to the new guidelines.
- (xxix)** Prospective bidders need to submit their bids with the most competitive Techno-commercial offer for the aforesaid work.



## **6. BIDS TO BE SUBMITTED:**

- Bids to be submitted in two-parts:
  - Pre-qualification Criteria
  - Financial Bid
- Pre-qualification Criteria and Financial Bid be submitted separately. If submitted physically, to be submitted in separate envelopes.

(Note: Pre-qualification Criteria and Financial Bid has to be submitted by all vendors. However, financial bid of only those vendors shall be opened who qualify the technical evaluation).

### **(i) Method of submission of bids:**

The vendors shall have the following options for submitting the bids:
